Last date of submission of the quotation is 12.02.2019 up to 2.00 p.m.

The sealed quotations will be opened on 12.02.2019 at the chamber of District Controller, Food & Supplies at 3.00 p.m.

The undersigned reserves the right to accept or reject any quotation without assigning the reason whatsoever.

The concerned suppliers whose quotation will be accepted must supply the selected commodities within 10 (ten) days from the date of receiving the supply order failing which their offer will be rejected without further notice.

The following conditions have to be pursued:-

- (i) Lowest rate will be accepted.
- (ii) Rice, Wheat, Musur Daal & Bengal Gram must be of best quality. Concerned selected suppliers will have to supply the desired quantity of Rice, Wheat, Musur Daal & Bengal Gram upto to the specified M.R Distributors point as will be advised in the concerned supply order.
- (iii) Supply order will be issued after receiving the proper sanction from the authority concerned time to time.
- (iv) Payment will be made through Treasury after delivery of Rice, Wheat, Musur Daal, & Bengal Gram and proper submission of the bills by suppliers duly endorsed by the concerned authority.
