***Sub: - Engagement of Paddy Purchase Personnel (PPPs).
Ref: - GO No.-149-FS/0/Sectt./DP/4M-24/2016 (Pt-1).***

With reference to the above GO this is to inform you that paddy purchase personnel (PPPs) will be engaged from amongst the unemployed youth i.e. Yuvasree beneficiaries, members of registered Self Help Groups and members of active households under MGNREGA on purely contractual basis on and from the actual date of joining till 30/04/2019 at the Centralized Procurement Centres (CPCs)/Direct Purchase Camp in the district Paschim Medinipur for KMS 2018-19.

The selected candidates will have to handle all the work at the paddy procurement centres like verification of documents of farmers, checking of FAQ paddy, entering procurement data in the department software, preparations of muster roll, dispatching paddy of rice mills etc.

As per annexure - I of notification no. 144 - FS/Sectt./DP/4M-24/2016 (Pt.-I) dated 11/01/2019 of the Commissioner in the Food & Supplies Department, Government of west Bengal the number of paddy purchase personnel (PPPs) to be engaged is 100 for 50 nos of additional camps. The block wise number of PPPs is enclosed at annexure 'A'.

Remuneration of contractually engaged Paddy Purchase Personnel (PPPs) will be ₹11,000/- per month. No extra remuneration will be admissible for working beyond normal office hours or for working of holidays.

The selection will be made purely based on merit as per the criteria and procedure mentioned below:

- 1) Age : 18 to 40 years as on 01/01/2019 (Age Proof : Date of Birth Certificate/ Madhyamik Admit Card)
- 2) Educational Qualification : i) Higher Secondary and above or equivalent.
ii) Basic computer knowledge skills. (Minimum Six months Certificate Course from any registered agency).
- 3) The applicant should be ordinary resident of the Municipality/ Block against the vacancy, he/she applies as on date of advertisement.

Criteria for Yuvasree : –Must be enrolled in Employment Bank of State Government and have valid Yuvasree ID number as on date of advertisement.

Criteria for Self Help Groups members :- Resolution Certificate of the Self Help Group.

Criteria MGNREGA Active Job Workers :- The MGNREGA Job worker must be engaged in work at least one year within last three years.

The properly filled up application forms along with self attested photocopies of necessary supportive documents from willing Yuvasree beneficiaries, SHG members and MGNREGA active job card holders of district would have to be submitted at the Offices of the respective Block Development officers. Yuvasree beneficiaries of municipal areas shall submit the applications to the office of the concerned Sub-Divisional Officers. BDOs and SDOs will issue notice accordingly, receive applications in their respective offices.

“Selection Committee” comprising of the BDOs as a chairman, any Block Extension Officer as nominated by the BDO and the Inspector (F&S) as member for the Block and in case of municipality the “selection committee” comprising of SDOs as a chairman, any DMDC as nominated by the SDO and the Inspector (F&S) as member for the Municipality, will short list the candidates @1:10 basis purely based on the HS marks of the applicants. The Higher Secondary marks will be considered after deducting the marks obtain in additional subject.

You are requested the complete the selection process by 20th of February'19 without fail and submit the list of candidates by 21/02/2019 to the office of the undersigned.
